ARTICLES OF INCORPORATION

OF

HARBOUR VILLAGE MARINA, INC. A NON-PROFIT CORPORATION

I, being of the age of eighteen (18) years or more, acting as incorporator for the purpose of creating a non-profit corporation under the laws of the State of North Carolina, as contained in Chapter 55A of the General Statutes of North Carolina, entitled "Non-Profit Corporation Act," and the several amendments thereto, do hereby set forth:

ARTICLE I

 $$\operatorname{\textsc{The}}$ name of the corporation is HARBOUR VILLAGE MARINA, INC.

ARTICLE II

The period of duration of the corporation shall be perpetual unless sooner dissolved according to law.

ARTICLE III

This Corporation does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for the maintenance, management, preservation and architectural control of that certain boatominium project known as HARBOUR VILLAGE MARINA as shown and described on the plat recorded or to be recorded in the Office of the Register of Deeds of Pender County, North Carolina, and any additions thereto which may be brought within the jurisdiction of the Corporation; and to promote the health, safety, welfare, social and recreational activities, and moral well-being of its members, and any

additions thereto as may hereafter be brought within the jurisdiction of this Corporation, and to exercise all of the powers and privileges and to perform all of the duties and obligations of the Corporation as set forth in that certain Declaration of Covenants, Conditions and Restrictions, hereinafter sometimes called the "Declaration", applicable to the property upon which HARBOUR VILLAGE MARINA, shall be located, which Declaration will be recorded in the Office of the Register of Deeds of Pender County, North Carolina, as such Declaration may be amended from time to time as therein provided.

ARTICLE IV

The corporation hereby formed shall have no capital stock and shall be composed of members rather than shareholders. Membership in the corporation shall be limited to such persons, firms or corporations as the By-Laws shall prescribe. Initial memberships shall be upon subscription to the incorporator. The transfer, assignment, lease or mortgage of a membership and any rights incident thereto shall be governed by the Declaration and the By-Laws. The classes of membership and all the rights, benefits, duties and obligations of membership within each such class shall be described by the Declaration or the By-Laws.

ARTICLE V

The Corporation shall be dissolved upon the affirmative vote of seventy-five percent (75%) of the members of each class.

The rights of members to the assets of the corporation upon dissolution shall be prescribed by the By-Laws.

ARTICLE VI

The affairs of the corporation shall be directed and governed by the Board of Directors of not less than three (3) nor more than seven (7) persons, each of whom shall be a

member of the corporation. The qualifications of Directors, the method of electing the Directors, and the number of Directors shall be fixed by the By-Laws.

Until the first annual meeting of members or until their successors are otherwise selected and qualified, there shall be three (3) directors whose names and addresses shall be as follows:
